Foster Care - LCFS supervises the care of between 1,500 to 1,900 of Illinois children whom the State of Illinois has removed from their biological homes because of abuse or neglect. LCFS identifies, trains, and licenses foster parents and provides ongoing training and home visits to ensure the well-being of each child in care.

4b (Code: _____) (Expenses \$ 7,062,178. including grants of \$ 77,996.) (Revenue \$ 6,268,913.)
Residential - LCFS is committed to helping children and youth, especially those who are at risk. We have two residential programs for youth who need specialized help. They are: Lutherbrook and Southern Thirty Adolescent Center (STAC).

Lutherbrook Child and Adolescent Center provides specialized residential treatment for children and adolescents with severe emotional and behavioral difficulties (stemming mostly from child abuse and neglect). Lutherbrook helps them learn to trust others and form positive relationships, especially with adults. The goal of treatment for each child is to resume family and community living.

Camp Wartburg - Camp Wartburg is a children's summer camp and year-round retreat center owned and operated by LCFS. Its mission is to provide an outdoor Christian ministry where people can encounter God and His creation. Over 7,500 children and individuals visited Camp Wartburg for camp retreats and outdoor education.
